A MUN resolution paper is the formal document produced and adopted by various UN bodies. In Model UN, it is a summary of the document that contains all the clauses written by the delegates during the simulation to be voted on at the end.

Washington State Model United Nations 2007. Resolutions. A resolution is a carefully drafted single sentence asking the assembly to express an opinion, affirm a policy, or take an action. It is a formal proposal made to the assembly by a delegate or group of delegates. If delegates wish to submit preliminary drafts of resolutions in the form of a working paper, they may do so once a committee session is declared open.
